As industry partners of the Society for Simulation in Healthcare (SSH), we believe that there are mutual benefits of a Corporate Roundtable. Our commitment to the SSH and to the other members of the council is that we will function in a capacity and manner that are beneficial for all involved. To that end, we believe that:

1. There is associational value for both the SSH and the Corporate Roundtable that enable all parties to achieve higher visibility and credibility with its members and existing and potential customers.
2. There are transferred values that occur between the parties, such as financial support, in-kind gifts, and customer access.
3. There is interaction value through relationships, producing innovative ideas and sharing of best practices, as well as opportunities to discuss organizational needs.

2. Recognize there is inherent conflict of interest risk as competitors in the marketplace.
3. Always act in a way that is both respectful of the SSH and upholds its mission, vision, and values.
4. Maintain professionalism and a demeanor of collegiality when dealing with other members of the Corporate Roundtable and / or the SSH Staff, Board of Directors, and its members.

5. Refrain from using our position as a member of the Corporate Roundtable to enhance any business transactions.
